TENANCY CHECKLIST – ALL PROSPECTIVE TENANTS MUST PROVIDE THE FOLLOWING

- 1. Application Form completed in full.**
- 2. Signed and completed guarantor form. A Guarantor can only be a Northern Ireland homeowner.**
- 3. Copy of photographic I.D. eg drivers licence or passport.**
- 4. Copy of student card (if applicable).**
- 5. Proof of employment eg current payslip.**
- 6. A copy of a bank statement.**
- 7. One months rent in advance and one months rent as security deposit to be paid prior to signing of contract and keys hand over.**
- 8. A £20 application fee per tenant – (non- refundable)**

The security deposit shall be retained by the landlord/ agent as security of performance of the tenants obligations. This deposit shall be repayable to the tenant only after the end of the tenancy and then without interest and after deduction of any sums required to compensate the landlord whether wholly or in part for any breach of obligation on the tenants part. The security deposit cannot be used as payment of last months rent.

Holding deposits will hold a property for 5 days and are non returnable if the tenancy is not taken up. Holding deposits will not be refunded if you change your mind.
